Appointment of Director

Adslot Ltd (Adslot; ASX:ADJ), a leading global innovator of digital media workflow and trading technology, is pleased to announce the appointment of Mr Andrew Dyer to its Board of Directors effective immediately.

In announcing Mr Dyer's appointment, Adslot Chairman Mr Andrew Barlow said, "The Company is very excited to have Mr Dyer join the Board at this critical time in the Company's evolution. Mr Dyer is a Senior Partner and Director of the Boston Consulting Group and brings a wealth of experience in strategy, organisation design and transformation, from which Adslot can immediately benefit. Specifically, Andrew is a world expert in change management – one of the critical success factors in driving adoption of Automated Guaranteed via Adslot's Media Marketplace trading platform."

Mr Dyer said, "I have joined the Adslot Board because of the disruptive role Adslot can play in the global digital advertising market. I am a strong believer in the business model as evidenced by my significant Adslot shareholding. Furthermore, I am very pleased with the tough and decisive decisions that the new leadership took to focus and streamline the business. I believe the sharpened focus and sense of urgency will accelerate the Company's prospects. Adslot is a true disruptor and is ready for its next step in its evolution."

In conjunction with his appointment as Director, My Dyer has been granted 4 million unlisted options to acquire fully paid ordinary shares in Adslot (Options). The exercise price of each Option is \$0.036 and the Options expire on 27 May 2022.

Two million Options will have no vesting conditions and will be immediately vested. The remaining 2 million Options will vest in four equal tranches of 500,000 Options at the end of each 6 month period from the date of appointment of Mr Dyer as Director.

Mr Dyer has agreed to waive his annual base director fees of \$50,000 per annum for the first two years of his directorship.
