Master Service Agreement with You & Mr Jones

Following a request from the ASX under Listing Rule 3.1, **Adslot Ltd** (ASX:ADS, "Adslot" or "the Company") is pleased to provide the following further information regarding the Master Service Agreement (MSA) executed with *You & Mr Jones*:

- As outlined in the CEO presentation to the Annual General Meeting in November 2021, the Company has a key strategic focus on securing MSA's with the eight largest and fastemerging global media agency holding companies, to drive trading on the Adslot Media marketplace;
- You & Mr Jones represents the second of the "emerging" agency groups, and, as disclosed, the Company now has commercial relationships to enable trading with seven of the eight target organisations;
- As with similar agreements executed with other agency groups, the MSA provides You & Mr
 Jones with the terms to access the Adslot Media platform and purchase inventory on behalf
 of advertiser clients from Adslot's contracted publisher partners;
- Whilst revenues from the *Adslot Media* marketplace are derived from fees charged to the sell-side (the publishers), the onboarding of large media buyers is the primary driver of growth in trading activity and therefore future revenues;
- There is no minimum spend commitments associated with the agreement;
- The Company anticipates that trading under this agreement will commence in the March 2022 quarter, although it is unable to provide guidance on expected trading volumes at this point;
- The term of the agreement is open-ended, with either party able to terminate the agreement with no less than 60 days notice;
- The Company can confirm that there are no material conditions that need to be satisfied prior to the commencement of client usage of the *Adslot Media* platform.
